

End User License Agreement (EULA) for use of L&G Electric s.r.o. software, cloud servers and services.

("L&G ELECTRIC" or "Licensor")

The language of the contract is German.

I. General information

L&G ELECTRIC software installed or pre-installed either on the AIO GATEWAY, Matter Bridge, on a computer or as an app on a smartphone or tablet, any third party software, documentation, user interfaces. Pre-installed, any third party software, documentation, user interfaces, content, fonts, extensions and any data associated with this license (collectively, the "L&G ELECTRIC Software "), whether downloaded from the Online Platform or stored on a data carrier, other storage medium or in any other form, is licensed, not sold, to you by L&G ELECTRIC for use under this license. L&G ELECTRIC and/or L&G ELECTRIC's licensors own and retain all proprietary rights, including patent, copyright and other rights, in and to the L&G ELECTRIC Software.

All trademarks, trade and domain names, logos and other intellectual property of L&G ELECTRIC are the exclusive property of L&G ELECTRIC. The license granted herein does not give you any right to commercial and/or private use thereof.

The terms of this License shall also apply to all updates, upgrades and any software updates (collectively, "Releases") provided by L&G ELECTRIC that replace and/or supplement the original L&G ELECTRIC software product, unless such update is covered by a separate license. In such case, the provisions of this License shall apply.

Ownership and copyright in the content displayed or made available through the L&G ELECTRIC Software belongs to the respective owners of such content. You are required to include on each copy of the L&G ELECTRIC Software the copyright and other proprietary notices that appeared on the original.

III Data storage and evaluation

The L&G ELECTRIC software collects a range of data to fulfil its purpose and stores this data and the configuration file locally on a PC, smartphone or tablet and, depending on the application and configuration case, partly also on the AIO GATEWAY/Server/Matter Bridge located on the local network. L&G ELECTRIC and L&G ELECTRIC's contractors collect and store diagnostic data as well as technical, usage and related information, including unique system and hardware identifiers and information about the system software used, software license, function modules (plug-ins) and all device and communication parameters controlled by L&G ELECTRIC software. This information is collected periodically primarily for the intended

functionality of the L&G ELECTRIC Software, but also to provide and improve L&G ELECTRIC's products and services, to enable and facilitate the provision of software updates, product support and other services (if any) in connection with the L&G ELECTRIC Software, and to verify compliance with the terms of this License Agreement. V. Consent to the collection, processing and use of personal data

If you have chosen to use the L&G ELECTRIC software in connection with the Services and have applied for or accessed an L&G ELECTRIC user account, you have also consented to L&G ELECTRIC collecting, storing, processing, using and transferring personal data within the meaning of Article 6(1)(1)(a) of the GDPR for the purpose of providing personal functions

such as visualisation of consumption data and operating conditions. This includes data such as name, address, email address, telephone number and, for example, consumption and equipment status data, even if they cannot be attributed to a specific person but are personal in nature due to the context in which they were collected. When the L&G ELECTRIC software or your AIO GATEWAY/ Matter Bridge integrated in the local network or other server connects to the services, L&G ELECTRIC collects, among other things, the following data: Any information you provided when you registered to create an L&G ELECTRIC user account , a list of devices with device categories, device types and/or manufacturer names that you have set up to be controlled by the L&G ELECTRIC software , any devices you use or have learned to use, device events, device status data, and other data. You may withdraw your consent to the collection, storage, processing and use of your personal data at any time free of charge, with effect for the future. Revocation is possible via the settings of the L&G ELECTRIC software by unchecking the box that states "I consent to the storage and processing of personal data".

This License Agreement shall remain in effect until terminated by notice or revocation. Upon termination of this License Agreement, your rights under this License Agreement will automatically terminate without notice from L&G ELECTRIC or will cease if you breach one or more provisions of this License Agreement. Upon termination of this License Agreement, you shall cease using the L&G ELECTRIC Software and destroy all copies of the L&G ELECTRIC Software or any portion thereof in your possession.

L&G ELECTRIC products are not suitable for use in medical or healthcare facilities or as a replacement for alarm and detection systems and do not require mobile equipment such as mobile devices for intended and contracted use. B. Smartphone or tablet with the latest Apple iOS or Android operating system. These restrictions do not apply if the use of the L&G ELECTRIC Software causes injury to life or limb or impairs the health or physical integrity of a person. Also, liability for claims under product liability law remains unaffected.

To the extent that liability for damages is excluded or limited in accordance with the foregoing provisions, this shall also apply to the personal liability of the respective employees, servants and bodies, as well as of the agents and their employees, servants and bodies.

Unless otherwise expressly stated above, the liability of L&G Electric is excluded.

VIII

By way of derogation from the statutory limitation period (Section 438(1)(3) BGB), if the licensee is a merchant, the general limitation period for claims for defects in fact and in law is one year from the acquisition of the licence. Otherwise, the statutory limitation period applies. This does not apply in the case of fraudulent concealment of a defect or the assumption of a warranty in this respect. Free or no-cost trials and upgrades of the L&G ELECTRIC software are not covered by any warranty. The exclusion does not apply to claims for damages arising from L&G ELECTRIC's gross negligence or wilful misconduct or for any injury to life, limb or health.

IX. Mixed

This license agreement is governed by the laws of the Federal Republic of Germany. In the event of changes that go beyond mere changes for legal or administrative reasons or the correction of an incorrect statement, L&G ELECTRIC will inform you of the changes in an appropriate manner (e.g. by posting the text on the website) seven days before the amended agreement becomes effective on the L&G ELECTRIC website, by e-mail or via information in the L&G ELECTRIC software and thus give you the opportunity to comment on the changes. By continuing to use the L&G ELECTRIC software, you agree to the amended license terms. These Terms of Use govern the relationship between you and MEDIOLA. No claims or rights to third parties arise.

If you do not comply with these Terms of Use and we do not take immediate action to comply, this does not mean that we waive any of our rights, such as the right to take action in the future.

In order to be effective, ancillary agreements must be in writing. This also applies to a change in the requirement of written form. If individual provisions are or become ineffective, this will not affect the effectiveness of the remaining provisions. In this case, the contracting parties shall agree on an effective regulation which is as close as possible to the common economic interest of the parties.

In the event of legal disputes, the place of jurisdiction is the registered office of L&G ELECTRIC if you are a licensed trader or do not have general jurisdiction in the Federal Republic of Germany or are a legal person under public law. L&G ELECTRIC shall be entitled to bring an action in any other place of jurisdiction provided for by law.
